In addition, any citizen who wishes to make a Presentation to the School Committee on a topic within the scope of the Committee's responsibilities may request to be placed on a future agenda at the discretion of the Committee Chair. Lastly, School Committee members also encourage citizens to contact them directly through email if questions or concerns arise regarding issues under the scope of duties for School Committee members.

The listing of matters is that which is reasonably anticipated by the Chair to be discussed at the meeting. Not all items listed may be discussed and other items not listed may also be brought up for discussion to the extent permitted by law.
